Thank you for making 2009 another great year to be a Friar!

It's hard to put into words the excitement and energy that was in the Dunk' when our men's basketball team shocked the #1 ranked team in the nation, the Pittsburgh Panthers. Our team accomplished something that hasn't been done at Providence since 1976 and the Friars instantly became the lead story on ESPN and on every major sports network in the country.

Friar Athletics continued to make national headlines in June when Danette Doetzel captured the NCAA Championship in the 10,000 meters competition. In her time at PC, Danette claimed five All-America honors, three BIG EAST titles, and two Northeast Regional cross country titles. Danette also became the 6th PC female student-athlete to win an NCAA title in the past 17 years.

As our accomplishments on the field continued, so did our standard of academic excellence. In 2009 our student-athletes posted a 94% graduation rate which places us among the best in the nation.

This is a special time in the history of Friar Athletics and last year a record 2,300 donors supported our programs and helped each of our student-athletes become the best that they can be.

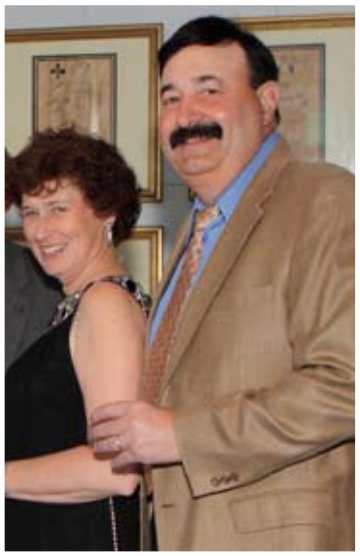

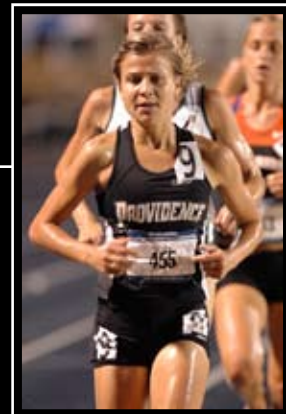


PROVIDENCE COLLEGE 81 PITTSBURGH 73
