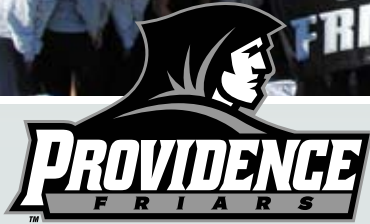


The men’s ice hockey team hosted a season kick-off party where fans and their families were invited to skate with the Friars and get autographs from their favorite players.

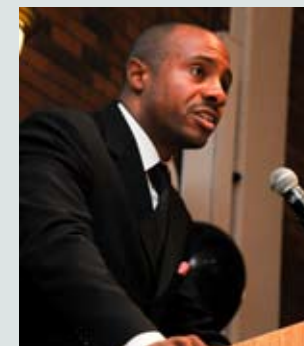

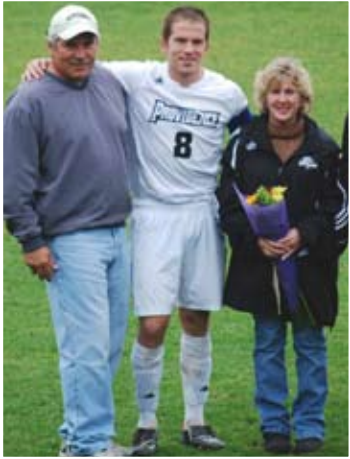

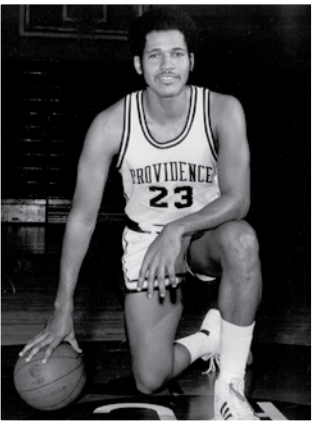
RIDING IN FRIARTOWN STYLE

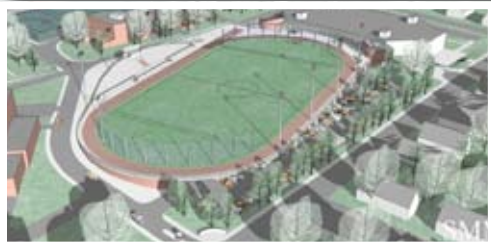
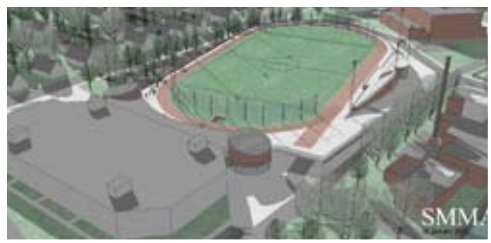

BROOKS NAMED WOODEN AWARD FINALIST, ALL-AMERICAN Brooks was chosen as one of 20 finalists for the John R. Wooden Award, the most prestigious individual honor in college basketball and was named FOXsports.com Fourth Team All-American. He was also selected to the All-BIG EAST Conference First Team, the USBWA District 1All-District Team, and the NABC Division 1 All-District 5 First Team. He is the first Friar to receive All-America distinction since Ryan Gomes ’05 in 2005. Brooks led the BIG EAST in overall scoring this past season averaging 24.6 points per game. He established the conference single-game and single-season scoring records. His 52 points against Notre Dame on February 23, surpassed the previous best of 48 by PC’s Eric Murdock ’91 in 1991 and tied the school record set by Marvin Barnes ’74 in 1973. Brooks was drafted by the Boston Celtics with the 25th pick in the NBA draft. He was traded to the New Jersey Nets where he will play this season.

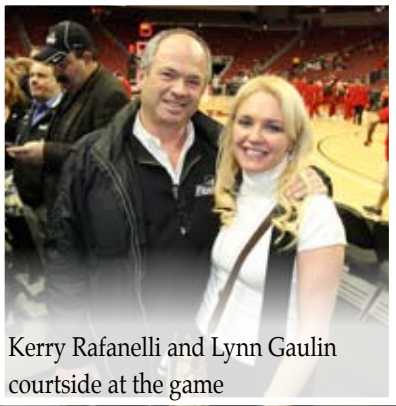
