2013 NCAA NATIONAL CHAMPIONS



On Friday, April 11, 2014, Providence College Athletics held a ribbon cutting ceremony to recognize the official opening of the track that is named after the legendary Friar head coach, Ray Treacy '82. The Ray Treacy Track is located on Hendricken Field and will serve as the home of the Providence College men’s and women’s cross country and track and field teams. The new complex has a six-lane lane track with eight-lane straightaways, which encompasses a turf field. The turf field can be used for soccer, rugby and other intramural sports. The complex has seating for more than 300 fans, as well as a press box and a scoreboard.

“The new track and field complex is an important addition to our program,” Providence College Director of Track and Cross Country Operations Ray Treacy said. “Not only will it benefit the track and field team, but the entire Providence College community will have use of this great facility. This track will allow us to continue competing at the highest level of NCAA competition.”

On Saturday, January 25, Providence College honored three of its all-time greatest basketball players. Former Friar men's basketball players Kevin Stacom '74 and Joe Hassett '77 and women's basketball player Tracy Lis '92 were honored at the men's and women's home games that day as banners were unveiled with their names and numbers (Stacom #25, Hassett #10 and Lis #22). All three former Friars joined the Friar Legends Forever Tradition. The Providence College Athletic Department also held a dinner to honor Stacom, Hassett and Lis. The event was held at the Omni Hotel in Downtown Providence.

The Friar Legends Forever Tradition began in 1996. Stacom and Hassett became the 10th and 11th members of the Friar men's basketball family to be honored as part of the Friar Legends Forever Tradition.

Lis became the second player in Providence College women's basketball history to have her jersey retired, and the third honoree overall. In 2010, former Associate Athletic Director Helen Bert and former Friar great Kathy Finn Hill '84 were honored.



FRIARS VS. KENTUCKY AT THE BARCLAYS CENTER

The Friar men's basketball team traveled to Brooklyn, NY on Sunday, December 1, 2013, to take on the Kentucky Wildcats at the Barclays Center. For the Friars, it marked their second meeting all-time against the Wildcats. The Friars will travel down to Rupp Arena in Kentucky this upcoming season for a rematch with the Wildcats, who lost in the National Championship game this past year.



FROZEN FENWAY

The No. 4/5 ranked Providence College men's hockey team skated to 1-1 overtime tie against Merrimack in a non-conference game at Fenway Park on Saturday, Jan. 4 as part of Citi Frozen Fenway 2014. Playing in the third installment of Frozen Fenway, the Friars and Warriors each made their first appearances in the event. Providence debuted throwback uniforms in honor of the 50th anniversary of the 1963-64 Friar squad that won the ECAC Championship and advanced to the Frozen Four, marking the first Providence team to win a conference title and advance to the NCAA Tournament.



2014 BIG EAST CHAMPIONS

The Providence College men's basketball team was crowned the BIG EAST Tournament Champion by defeating No. 14 Creighton, 65-58, in the Championship Game, on Saturday, March 15 at Madison Square Garden. Senior Bryce Cotton was named the BIG EAST Championship's Most Outstanding Player. It was Providence's second BIG EAST Tournament Championship in the 35-year history of the BIG EAST. The Friars also captured the title in 1994, when they defeated Georgetown on March 13, 1994. With the Championship win, the Friars earned an automatic berth into the NCAA Tournament as the No. 11 seed where they took on sixth-seeded North Carolina in San Antonio, Texas. The Friars made their 16th appearance all-time in the NCAA Tournament and its first appearance since 2004.



FOX Sports 1 is the nation's newest and most innovative 24-hour multi-sport channel, and the launch of FS1 on August 17, 2013 represented the largest sports network launch in history. The alliance between FOX Sports and the BIG EAST is perfect, given the shared passion for college basketball and the mutual desire to produce live sports programming that provides high-quality entertainment and puts the fans first. From the first practices through the regular season and culminating with the nation's most compelling conference basketball tournament, held each March in Madison Square Garden, FOX Sports 1 showcased the high level of competition and the intense rivalries that have long defined BIG EAST basketball. The legendary announcing team of Gus Johnson and Bill Raftery, who have been calling BIG EAST games for over thirty years, led Fox Sports 1 through its first season airing BIG EAST basketball games.

Fox Sports 1 captured video from the Friars Late Night Madness event for its BIG EAST Tip-Off Party that aired live that night from 9:00 to 11:00 pm. DJ Nick Cannon was featured during Late Night Madness and this provided the Friar basketball programs with great exposure that night in front of a national audience. Fox Sports 1's college basketball debut was on November 8, 2013 broadcasting the Friars 82-78 overtime victory over Boston College. FS1 included a new year's eve Big East Marathon where Big East games were televised for 12 hours. FOX Sports 1 televised more than 100 BIG EAST men's regular season games this past season.

10 Friar volleyball players were named to the America East Fall Honor Roll. Student-athletes had to earn a GPA of 3.0 or better.

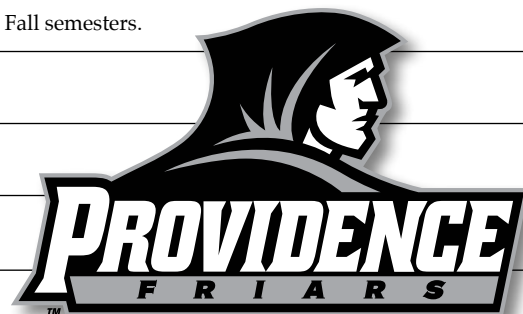
