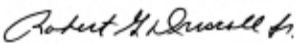

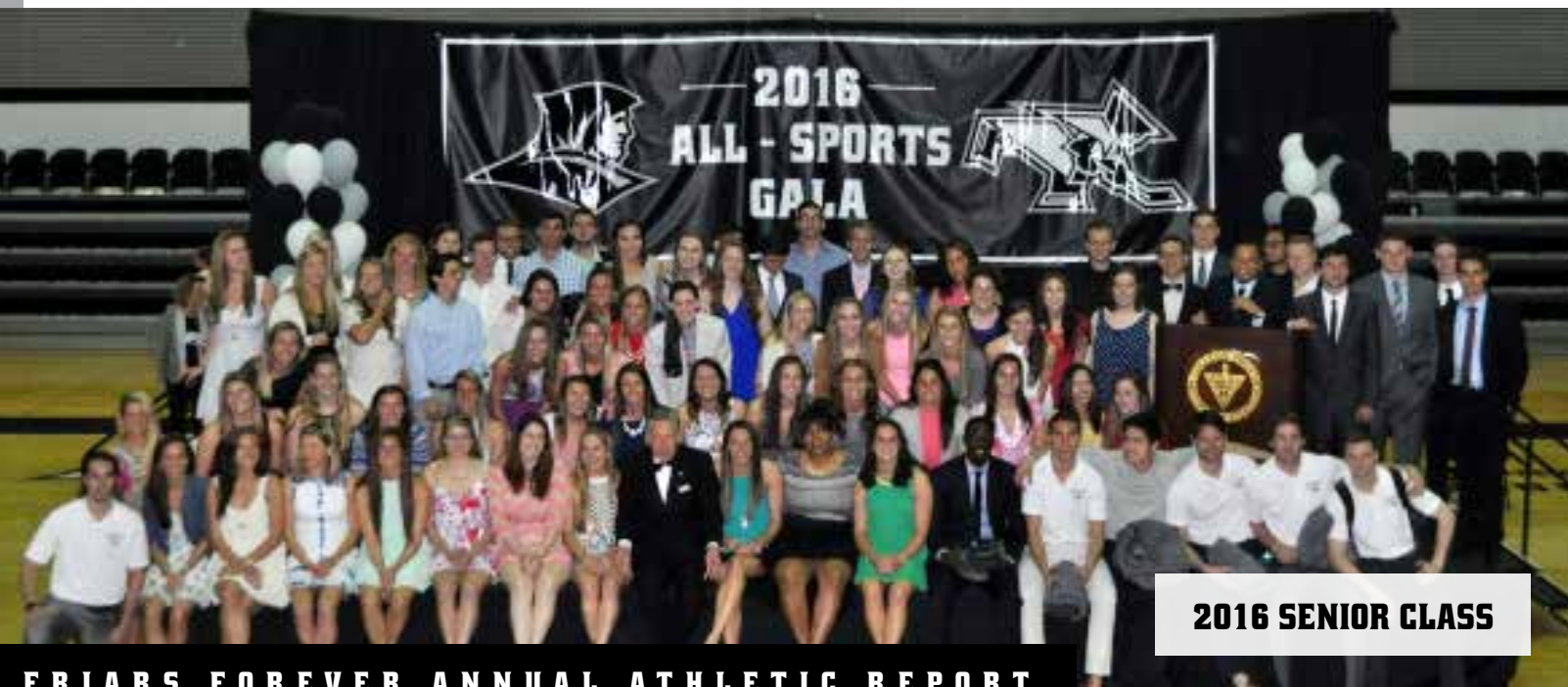

2016 NBA DRAFT

Thursday, June 23, 2016 was a historic night for the Providence College men's basketball program. Former Friars guard Kris Dunn (New London, Conn.) & forward Ben Bentil (Wilmington, Del.) were selected in the 2016 NBA Draft.



Dunn became the highest Friar selected in the NBA draft since Marvin Barnes was picked second in 1974. Dunn was selected fifth by the Minnesota Timberwolves, which also marked the fourth highest a Friar has been drafted all-time (Jimmy Walker, No. 1, 1967; Marvin Barnes, No. 2, 1974; & Ernie DiGregorio, No. 3, 1973).

"Providence & New London are my home," Dunn said. "Both those cities have been such big part of my life. I will never forget what it means to be a Friar & all the great fans in Friartown. I am looking forward to this next step in my career & playing for the fans in Minneapolis."

INTRODUCING HEAD COACH JIM CROWLEY

Jim Crowley was introduced in May as the new Friar women's basketball coach. The tenth head coach in the program's 42-year history, Crowley comes to Providence after 20 successful seasons coaching the St. Bonaventure Bonnies, 16 of them as head coach. During his tenure at St. Bonaventure, Crowley posted 20 or more wins in six of the last eight seasons & led the program to its first appearances in both the WNIT & NCAA tournaments. He was named A-10 Coach of the Year three times & National Coach of the Year in 2012.



"We believe that Jim fits all the criteria we looked for in a coach to build our women's basketball program." Over the last five years we have brought in some very successful coaches & we feel that Jim has a similar pedigree. Our goal for the Friar women's basketball program is to win a BIG EAST Championship & compete in the NCAA Tournament." - Athletic Director Bob Driscoll

The men's ice hockey team earned the Hockey East regular season title as a tie with Boston College for first in the Hockey East standings & a share of the crown, the first in program history. The 16 Hockey East wins are the most in the season for the program.
